- 1. This document states the complete information of date of submission & opening of tenders, period allowed for the work etc.
- 2. The tenderers shall be deemed to have studied the items, specifications and details of the supplies to be made within the time schedule attached and to have acquainted himself/ themselves with the conditions attached. The tenderers/their representatives are permitted to be present at the time of the opening of the tenders.
- 3. The tenderer shall quote rates inclusive of all taxes etc as applicable, whatsoever. Rates quoted should include Application Development, Third Party Software Licenses, Support etc. and all kinds of taxes, GST, etc. Separate mention for these activities and taxes will not be accepted.

Incomplete / Conditional tenders are liable to be summarily rejected. However, the undersigned reserves the right to decide on such a matter in the interest of the Sangathan, if felt necessary.

- 4. The rates are to be quoted in Indian Rupees only. The tenderer shall quote the prices both in words in figures. In case of difference in words in figures, the rates offered in words shall prevail for consideration.
- 5. The rates quoted by the contractor shall hold good and valid for one year. However, the rate contract may be further extended on mutual consent, as deemed fit. No amendment in the rate except increase in the rates of GST during the period of execution of the contract will be accepted.
- 6. There should not be any overwriting or corrections in the tenders. If the figure is required to be amended, it should be neatly scored out, the revised figure written above and the same attested with signature and date; otherwise their tender will be liable for rejection.
- 7. The sample of the Screens of the Student and School dashboards is required to be submitted with tender duly stamped with SEAL of the firm. The software may be got tested, if felt necessary. If the software is not found as per specifications in the finished product. In addition to the forfeiture of performance security, tenderer shall be penalised by either rejecting the software or penalty of proportionate cost, as may be decided by the undersigned while reserving all the rights in this regard, further without prejudice to blacklist the Service Provider accordingly, if deemed fit.
- 8. In the event of acceptance of the quotation and placing of the order for purchase, the articles ordered may be subjected to an inspection by the undersigned or representatives and are liable to be rejected if the articles supplied are not according to the approved samples or do not confirm to the specifications prescribed.
- 9. The agency should have at least one single software development unit. The software development facilities of the firm may be subjected to physical inspection by the team authorized by Kendriya Vidyalaya Sangathan, if required. The firm owning the original software will be treated advantageous for speedy completion of works, if other conditions are same. As such, the facility layout may be attached.
- 10. The firm/organisation must have the sufficient experience in similar job of data analytics. At least two copies of work orders during the two financial years (2015-16 and 2016-17) from Central/State Govt./PSUs/Reputed Organisations be attached. However, the undersigned reserves the right of any discretion in this regard.
- 11. It would not be binding upon the authority to accept the lowest tender. The authority reserves the right to accept the tender in whole or in part, as may be decided. Any dispute shall be subject to the jurisdiction of appropriate Hon'ble Courts in Delhi.

Bid Security :

- The Security of Rs 25,000/- (Rs. Twenty Five Thousand only), will be deposited by the tenderer through bank DD / Pay order drawn in favour of the "Kendriya Vidyalaya Sangathan New Delhi". The tenders without enclosing Bid Security will be rejected summarily. The quotations without Bid Security, will not be accepted.
- 2) The Bid Security of those firms whose tenders are not approved will be refunded. However, no interest will be payable by Kendriya Vidyalaya Sangathan.
- 3) Performance Security Deposit : The successful bidders will have to deposit the performance security at the rate of 5% of estimated value within a week's time from the date of the award of the contract and should be valid up 60 days after the date of completion of contract. The amount of Bid Security will be refunded on receipt of performance Security. If the accepted firm/organisation fails to remit the Performance security within prescribed time, the Bid Security remitted by him will be forfeited and his bid may be held void. The performance security will be released only after the successful completion and final payment of the job. - 5) The successful bidder will maintain the data confidentiality and not part with the data/information in part or whole in any explicit or implicit firm or agency or person. Any violation in this regard will be treated as breach of trust and the Kendriya Vidyalaya Sangathan would be free to impose penalty and or any action ad deemed fit as per rules.

Tolerance Clause

While it is expected that the number of users will be within variation of 10%, the purchaser reserves the right for any variation in the number of users while placing the supply order for each assessment cycle. The rates quoted will apply in all circumstances.

Unresponsive tenders

The following kind of tenders will be treated as unresponsive tenders :

i. Not meeting the qualifying criteria i.e. carrying required financial status, regd with the appropriate authorities for carrying out the described works, furnishing the declaration regarding blacklisting on stamp paper etc.

 - 3. Consistency of Performance i.e. Tracking for Fitness Levels over Years/Camps (each fitness parameter tracked).

3. Tracking will include:

- a. Track records of all children and view based on fitness levels
- b. Analyze by Levels of Fitness of Children.

- c. Tracking for Fitness Levels over Years/Camp
- d. Analyze overall improvement of fitness of any School/School Chain or Academy or Fitness Assessment Partner
- e. Comparison between Regions /Zone, Age Groups, Class-wise Comparisons etc.
- f. Identification of Sports Fit children and Identification of children who need attention
- g. Consistency of Performance i.e. Tracking for Fitness Levels over Years/Camps (each fitness parameter tracked)
- h. View National Benchmarks of Fitness (each Age-Gender has a benchmark
- i. Define recommended Physical Activity and Lifestyle Changes
- j. Appropriate communication with parents and students
- k. Define Fitness Zone standards based on data captured over time, and defining appropriate grade level use of health-related fitness assessment

- 3. Training to be done in following manner
 - a. The Vendor will do National/Zonal Level Training of 100 Trainee Trainers from different ZIETs, in batches of 50 in 2 different locations identified by KVS (accommodation, travel and incidental expenses will be paid by KVS)
 - b. Further Zonal Level, Regional Level, Cluster Level and Vidyalaya Level Trainings for School PE Teachers/Fitness Assessors to be conducted by these Master Trainers.
- 4. Upon successful completion of training and clearing the test, Certification will be given by KVS and Vendor to the Master Trainers.

Considerations

- 1. Assessment Application to work in remote villages in Offline Mode as well, with Data getting synced whenever there is connectivity
- 2. Flexibilities Required in the software
 - a. The software must be capable of defining or modifying the battery of fitness assessment tests for all children or sports specific fitness assessment. Types of Fitness Tests that can be defined/altered through the Application for any of the Physical Fitness components:
 - i. Fundamental Movement Skills (Observation-based)
 - ii. Health Components of Fitness
 - iii. Skill Components of Fitness
 - b. Provision in App for defining new set of Tests
 - c. Points Scale for Fitness Test
- 3. Server Infrastructure

- a. To be hosted on a Dedicated KVS Server/ Data Center (DC) (hosting of application will be responsibility of the schools)
- b. Vendor to ensure a Scalable and Flexible Architecture, with highly optimised Application DB, Web Services and Storage
- c. Performance Requirements: Performance requirements: The number of the online users of can be estimated as 12.5 Lac children. So, the Infrastructure to scale up as required, to potentially capture fitness data of these children each year and run the Mobile App and Analytics seamlessly. Application, Security Hardware and Bandwidth should cater to growing number of new schools, students and other users.
- d. No. of Concurrent Users to be considered at 1%. In case the usage increases (as per monitoring of servers), there needs to be provision to upscale the Hardware and Bandwidth requirements accordingly

4. Non-functional Requirements

- a. Security and VA: Industry standard security should be used to secure data.
- b. Coding: Follow industry standard coding process. Like proper comment, exception, message etc. should be followed.
- c. Platform/Browser independence: The web application should be able to work on any of the modern browsers like Firefox / Explorer / Opera /Chrome, and of the common Operating Systems like Linux and Windows.
- d. Data migration: There should be an easy way to migrate data from the current manual system to a new system. The system should be able to interface with Microsoft Excel for both import and export.
- e. Flexibility: It is desirable to have a system that is flexible enough to allow the developer to convert code in higher version of technology. So, Coding standard should follow accordingly.
- f. Ease of use and Documentation: The software should be designed for extensive customizability. The user-interface should be intuitive and easy to navigate. There should be a proper documentation of the system. This document should be so simple yet precise so that a newly appointed developer/user should do all the things easily.
- g. Audit Trail: History and tracking facilities, maintaining an audit trail.
